

## **GBAYBSA CODE OF CONDUCT**

**THE CODE OF CONDUCT WILL APPLY TO THE FOLLOWING PERSONS: PLAYERS, MANAGERS, COACHES, FAMILIES, AND ANY OTHER MEMBERS OF THEIR APPROPRIATE LEAGUE. SPORTSMANSHIP IS THE TOP PRIORITY FOR EVERYONE INVOLVED WITH ALL THE LEAGUES.**

**THESE RULES WILL BE USED AS A GUIDELINE FOR ALL LEAGUES. EACH LEAGUE HAS THE OPTION OF VARYING THESE RULES.**

### **PARK RULES:**

**Alcoholic beverages**-No person shall possess, consume, or offer for sale of any alcoholic beverages on City of Green Bay owned property. This includes Parks and/or School property.

**THIS WILL BE ENFORCED BY THE POLICE DEPARTMENT**

**Controlled Substances**-No person shall possess, use, or offer for sale or sell any controlled substance on City of Green Bay owned property. This includes Parks and/or School property.

**THIS WILL BE ENFORCED BY THE POLICE DEPARTMENT**

**Littering**-No person shall place or leave any paper or refuse in the dugout area. The garbage shall be put in the containers provided.

**THIS RULE WILL BE ENFORCED BY THE COACH(S) AND/OR THE COMMISSIONER**

### **PLAYERS RULES:**

No player shall use any alcohol or tobacco products

**PENALTY: FIRST OFFENSE**-Automatic ejection for the rest of the game and must leave the dugout area.

**SECOND OFFENSE**-The player will not be allowed back for the rest of the season.

No player shall use any offensive language and/or behavior towards players, opposing players, coaches, or the umpires. No player shall harass or do any name calling to any player(s), coach(s), or umpire(s)

**PENALTY: FIRST OFFENSE**-Team will be warned the first time. **SECOND OFFENSE**-Player is ejected for the remainder of the game and will owe an apology to the offended person(s) before being reinstated for the following game.

**NOTE: CERTAIN WORDS, PHRASES, ETC..., DIRECTED AT AN UMPIRE WILL BE AN AUTOMATIC EJECTION. THIS WILL BE AN UMPIRES DECISION**

No player shall kick or throw equipment on the playing field or dugout. If the kicked or thrown equipment is directed at a player or an umpire, this will be an automatic ejection.

**PENALTY: FIRST OFFENSE**- Team will be warned the first time. **SECOND OFFENSE**-Player is ejected for the remainder of the game and will owe an apology to the offended person(s) before being reinstated for the following game.

**NOTE: THIS IS A WIAA/ASA RULE**

No Pitcher shall deliberately throw a pitch to hit a batter. No batter shall deliberately make a movement to the pitchers mound to retaliate.

**PENALTY:** One or both players will be automatically ejected for the rest of the game and must leave the dugout area.

All base runners must try not to purposely collide with a fielder or catcher.

**NOTE: THERE ARE NO WIAA/ASA RULES THAT BASE RUNNERS ARE REQUIRED TO SLIDE**

**PENALTY:** Umpire will have final say on any penalties

No fake tags allowed. They are illegal and dangerous. This comes under the obstruction rule

**NOTE: THIS IS A WIAA/ASA RULE AND WILL BE ENFORCED BY THE UMPIRE(S)**

Metal spikes will be allowed in the 14-16 year old baseball league.

No metal spikes will be allowed for baseball leagues up to the 13 year old Babe Ruth League and all Softball Leagues.

**PENALTY:** The player will be allowed to change shoes and come back into the game.

**THE UMPIRE(S) WILL ENFORCE AND HAVE THE FINAL SAY ON THE RULES.**

#### **COACHES RULES:**

No coach shall use any alcohol or tobacco products

**PENALTY: FIRST OFFENSE-**Automatic ejection for the rest of the game and must leave the dugout area.

**SECOND OFFENSE-**The coach will not be allowed back for the rest of the season.

**NOTE: ANY COACH USING ALCOHOL COULD BE SUBJECT TO FINES FROM THE POLICE DEPARTMENT.**

**THE POLICE WILL BE NOTIFIED AND REMOVE THE COACH FROM THE PROPERTY.**

No coach shall use any offensive language and/or behavior towards players, opposing players, coaches, or the umpires. No coach shall harass or do any name calling to any player(s), coach(s), or umpire(s)

**THE UMPIRE(S) WILL ENFORCE AND HAVE THE FINAL SAY ON THE RULES.**

#### **SPECTATOR RULES:**

No spectator shall use any alcohol products and/or controlled substances with in the ball diamond area

**PENALTY:** Any spectator who is considered under the influence shall be escorted off of the property and subject to fines from the Police Department. The Police will be notified and remove any spectator from the property.

No spectator shall use any tobacco products with in the ball diamond area. If any spectator needs to smoke, they are to move to an area that won't interfere with players, coaches, umpires, other spectators that don't smoke. The preferred area would be in the parking lot area, or near the street.

No spectator shall use any offensive language and/or behavior towards any player(s), coach(s), or umpires. No spectator shall harass or do any name calling to any player(s), coach(s), or umpire(s)

**THE UMPIRE(S) /COMMISSIONER/COACHES WILL ENFORCE AND HAVE THE FINAL SAY ON THE RULES.**

#### **ANY PERSON REMOVED BY THE POLICE DEPARTMENT**

**FIRST OFFENSE-**If any person is removed by the Police Department, they will not be allowed back for one game

**SECOND OFFENSE-**That person will not be allowed back for the remainder of the season

**ANY APPEALS FOR SUSPENSIONS AND/OR EJECTIONS SHALL BE MADE IN WRITING OR WITH A FACE TO FACE MEETING WITHIN FORTY EIGHT (48) HOURS TO ANY EXECUTIVE BOARD MEMBER OR COMMISSIONER OF EACH LEAGUE FOR POSSIBLE REINSTATEMENT. ANY LEAGUE MEMBER REMOVED FROM THE LEAGUE SHALL NOT BE ALLOWED TO RE-ENTER THE LEAGUE WITHOUT EXECUTIVE BOARD OR LEAGUE COMMISSIONERS APPROVAL. THE UMPIRE(S) WOULD HAVE THE OPTION TO ATTEND THE APPEAL PROCESS.**

**HOLD HARMLESS AGREEMENT**
